Statement on corona virus issue - status week 16/2020

Dear Ladies and Gentlemen,

In the Maghreb countries of North Africa the Covid-19 pandemic encounters an extremely fragile and ill-prepared health care system which entails that these countries seal themselves off and impose extensive curfews as preventive measures. The Tunisian government has previously terminated these measures from March 23 until April 19. A decision about a possible annulment or even extension of these measures is expected to be announced by the end of this week.

Kaschke exceedingly feels obliged to the health and well-being of its employees, especially in the context of these difficult conditions, and supports it on various levels. Amongst other things we have determined a social pact with our employees and pay transitional allowance during the shutdown. Furthermore the workplaces, social areas and sanitation are being modified to be "Corona-equitable", so that, after a re-start of the production, infections can be prevented as effective as possible.

With the aid of a legal means as well as support letters from several of our customers we intermediately have managed to negotiate a special agreement with the local authorities, at least for one of our production site in Tunisia. Therefore we exclusively produce components for system relevant, medical modules and equipment in our 'Factory 3' since last week with a fraction of our workforce (approx. 4%). Furthermore we constantly try to extend this special agreement on the other Kaschke factories.

In this extraordinary situation we would like to ask you for your understanding that through these measures our reactivity will be significantly limited and that it will lead to massive delays in processing and executing of activities at all levels of our business.

The overall situation is still extremely tense – we will keep you updated!
