Statement on corona virus issue - status week 18/2020

Dear Ladies and Gentlemen,

The announcement of the Tunisian government of April 19 still endures to end the shutdown and enable all export companies to successively start their activities on May 4.

Kaschke still uses the remaining time to take all necessary precautions, so that the health and well-being of the employees will be top priority while returning of all production sites into normal operation. There is still the risk of a corona infection among the workers and therefore forbids any negligence and sudden, unconsidered action.

It is our scheduled target as from next week (cw 19/2020) to resume production in our factories with approximately 50% of the staff and to continuously increase the percentage. As for the fact that the Islamic month of fasting, Ramadan, began on April 24 our daily working hours will be 9 hours in 2 shifts until May 24.

We would like to point out that, due to the intermediately accrued backlogs and the explained ramp-up scenario as from week 19, we will exclusively take care of the most urgent parts (preferably for critical infrastructure respectively system relevance) and will not be able to serve all customer's wishes immediately.

For this reason we would like you to critically question your backlog of orders and tell your contact in our Sales Department the parts with very most priority. Please restrict it to the absolute minimum per calendar week! This will ensure that we can help as much customers as possible on short-term basis.

In this extraordinary situation we would like to ask you for your understanding that through these measures our reactivity will be significantly limited and that it will lead to massive delays in processing and executing of activities at all levels of our business.
